An intense, five-month progressive entrepreneurship program, each NLC Institute is highly selective, admitting only 15 to 20 fellows in each chapter. Each of NLC's 35 chapters hosts the NLC Institute, and is totally volunteer run by local leaders. The program is a free educational institute for young professionals, hosted on the ground by local leaders and advisors, with support from a national staff who provide guidance, mentorship, and support to the training program. NLC recruits its Fellows and chapter leaders from outside of traditional power structures, thereby equipping individuals who would otherwise fail to have such opportunities with the skills necessary to be civic leaders in their communities, states, and nation to build a stronger community, state and national democracy, network of social justice, and equal opportunity for all.
